
The significant developments are as under:

Growths in Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Atal Pension Yojana (APY)

Till date 1055 banks including Public and Private Sector, RRBs, Cooperative and foreign banks have tied up with 10 life insurance companies and 1045 banks have tied up with 10 general insurance companies for PMJJBY & PMSBY under the universal social security system for all Indians, especially the poor and underprivileged. An extensive media based campaign was undertaken to create awareness about the schemes including disseminating the material in Hindi, English and Regional languages. A simple claim settlement procedure/ process involving minimum documentation has been put in place for minimising settlement time and large scale awareness generation has been undertaken to this effect.




As far as APY is concerned, a total number of 109.18 Lakh people have enrolled as on 28.07.2018 under this scheme.


