



Major Achievements, significant developments and important events for the month of August, 2018

PradhanMantriJeevanJyotiBimaYojana (PMJJBY) and Atal Pension Yojana (APY)

Till date 1055 banks including Public and Private Sector, RRBs, Cooperative and foreign banks have tied up with 10 life insurance companies and 1045 banks have tied up with 10 general insurance companies for PMJJBY & PMSBY under the universal social security system for all Indians, especially the poor and underprivileged. An extensive media based campaign was undertaken to create awareness about the schemes including disseminating the material in Hindi, English and Regional languages. A simple claim settlement procedure/ process involving minimum documentation has been put in place for minimising settlement time and large scale awareness generation has been undertaken to this effect.

As on 04.09.2018 gross enrolment by banks, subject to verification of eligibility criteria, is as under:






As far as APY is concerned, a total number of 112.70 Lakh people have enrolled as on 01.09.2018 under this scheme.
